

Education and Children's Services

1061 children from **975** families received services through Community Action's Head Start and Early Head Start Programs.

The Impact: Community Action provides a quality education along with opportunities for social and emotional growth for children and their families. We provide valuable resources and support for low and moderate- income families throughout the child's time at Community Action so that each child will enjoy the same advantages as their peers from the beginning of their lives.

Of the **911** children served in Head Start:

78% were income eligible
11% were eligible due to receipt of public assistance
2% were eligible due to foster child status
2% were eligible due to homelessness
7% were over-income

Average daily attendance was 86%

Of the **150** children served in Early Head Start:

76% were income eligible
10% were eligible due to receipt of public assistance
1% were eligible due to foster child status
7% were eligible due to homelessness
6% were over-income

Average daily attendance was 87% 67% of children had an ongoing source of medical care 35% of children received preventative dental care



Children and families receive extra support through family engagement activities. For example, **262** individuals participated in Fatherhood and Male Involvement Program activities during 2015.

178 children had special education identified disabilities.


86 seniors spent a total of **68,573** volunteer hours acting as tutors and mentors for children in **38** local schools through the Foster Grandparent Program in 2015.







2015 Early Head Start Source of Revenue







Community Action is proud that our Head Start program adequately prepares children for kindergarten. Our qualified classroom staff is trained in curriculum, behavior management, social and emotional development, and self-regulation. Community Action collaborates with local school districts to ensure that we are in alignment with experiences children will have in kindergarten. Kindergarten teachers attend family night to aid in the transition from Head Start to kindergarten. We also ease the transition by taking children on field trips to kindergarten classrooms. These fieldtrips allow children to participate in an active kindergarten classroom environment.

1031 households received utility assistance across Barry, Branch, Calhoun, and St. Joseph Counties.

44% of households had children living in the home, and **30%** had at least one senior residing in the home.



59 homes received major updates, including: new siding, insulation, and new roofing through our Home Rehabilitation/Repair program. In total, these repairs valued \$636,901.



62 families received services such as sealing air ducts, door frames, etc. valuing **\$418,524** to help increase a home's energy efficiency through Community Action's Weatherization program.

Housing and Support Services



The Impact: Community Action offers emergency assistance, weatherization, home rehabilitation, and home repair programs in order to assist families who are struggling to make ends meet or are in need of essential repairs and updates to their homes. These services encourage safe and sustainable housing, allowing family assets to be focused on other basic needs. Transportation services assist clients in staying independent and in their homes by providing door-to-door transportation services for everything from medical appointments to social outings.

The Walk for Warmth campaign raised \$50,302 to help keep the heat on in Community Action's four-county service area.

Food and Nutritional Services

The Impact: Community Action provides food and nutritional education to those eligible through a variety of programs including The Emergency Food Assisstance Program (TEFAP), Commodity Supplemental Food Program (CSFP), Congregate Dining, and the Home Delivered Meal Program. These programs help thousands of individuals and families stay independent. Providing these services helps ease the burden of choosing between food, medication, utilities, and other essentials for survival.

147 homebound seniors received a total of **22,437** meals through the Home Delivered Meals program in Branch County.

191 seniors received a total of 4,456 hot, nutritious meals through the Congregate Dining program in Branch County.



Community Action provided **\$240,305** in services through the Home Delivered Meals and Congregate Dining programs.

Community Action prepares and serves meals to Congregate and Home Delivered Clients that meet current USDA Health and Human Services Dietary Guidelines. Menu standards are developed to sustain and improve a participant's health through the provision of safe and nutritious meals. Each meal contains 33 1/3% of Dietary References Intake (DRI) and has a variety of components including fruits, vegetables and whole grains.



5,003 families received a total of 13,818 boxes of non-perishable food items through the quarterly distribution of The Emergency Food Assistance Program (TEFAP).

3,017 seniors received a total of 27,297 boxes of non-perishable food items through the monthly Commodities
Supplemental Food Program
(CSFP) distribution.

Community Action provided \$303,398 in food items through CSFP and TEFAP in the 2015 grant year in Barry, Branch, Calhoun, Hillsdale, Jackson, Lenawee, and St. Joseph Counties.




Community Action Financials
